On 01.02.2024 there was organized the first meeting within our project action GTA. The meeting was attended by 16 participants (7 female, 9 males). Mr. Piotr Ostrowski - President of All Poland Alliance of Trade Unions opened the meeting welcoming the participants and introducing the aim of the meeting. President - also acting as the project manager, pointed out how crucial issues regarding green transition can impact the functioning of trade unions. Mr. Ostrowski indicated that the main goal of the project is to build the capacity of stakeholders to use information, consultation, and participation tools in the workplace, ensuring effective engagement of workers in decision-making processes related to the green transition and taking into account their interests, thereby addressing the second priority of supporting worker involvement in the anticipation and management of change and the prevention and resolution of disputes in the event of various forms of restructuring.

The partners have presented themselves and in the next step Ms. Anna Fastyn – Chief Specialist, Trainings and Structural Funds in OPZZ presented the main project objectives, expected results, work program, planned the dates and content of the project events and outputs to be produced. The presentation is enclosed to the Minutes.

Also next steps in the project were discussed in details:

- Promoting the project in partner countries by disseminating project information on the websites of organizations as well as on social media;
- The leader will prepare a detailed task allocation and an appropriate schedule for implementation;






- In the near future, the leader will propose the scope of the partnership agreement, outlining the specific terms of cooperation, the budget available to each partner, and the method of financial fund transfer.
